

Having an upgrade to Dynamics 365 on your roadmap is imperative. Extended support for the latest **Dynamics AX 2023 R3** ended on January 10, 2023. This means you no longer receive regulatory updates or security hotfixes for any version of AX software, leaving you more vulnerable to security threats and reducing your options for support if critical issues arise.






